



# INTEGRATING SEXUAL AND REPRODUCTIVE INFORMATION AND RESOURCES FOR SUSTAINED EFFORTS TO EMPOWER NIGERIAN GIRLS (PROJECT INSPIRE)

### **Data Analysis from Delta State Research**

Delta State is one of the states in the Southern Region of Nigeria and is governed by the Criminal Code of the Laws of The Federal Republic of Nigeria. The provisions of the criminal code only allow an abortion if the life of the pregnant person is in danger.

Delta State is known to have a significant level of adolescent pregnancies and birth rate. According to MICS, Nigeria 2016-17, Delta state has a birth rate of 57% among adolescent girls (age 15-19). Interactions with respondents on the field revealed that most of such pregnancies are known to be terminated in the state but by quacks who are not professionally trained or who do not have the standard facilities for safe termination of pregnancies.

This research study was aimed at understanding the scope of medical abortion in Delta State and to understand the level of availability of abortion services, how the media can be able to report on abortion and expanding the cadre of medical abortion service providers in the state.

The activity was carried out in Oshimilli South, Delta state. Respondents that partook in the activity, included civil servants, market women, young boys and girls, health care providers and some senior citizens.


Find below the result gathered and the analysis.






1. From the image below, majority of the respondents (84.7%) agreed that abortion is the termination of pregnancy before foetal viability.

#### Abortion is murder and should be criminalized 202 responses




2. A huge number of respondents felt that abortion is murder and should be a criminal offence.

About 10% of the deaths in Nigeria are a result of unsafe abortion 202 responses








4. Based on the chart below, most respondents felt many women die from complications as a result of unsafe abortion.

Many women/girls die and have severe complications as a result of unsafe abortion 202 responses



Do you think there are cases that would require a pregnancy to be terminated ? 202 responses








6. More than half the respondents agreed that women gathering and social clubs should discuss unsafe abortion.


Do you think women gatherings and social clubs should discuss unsafe abortion and its consequences from time to time?

7. 183 respondents agreed that young girls face the most consequences of unsafe abortion.


Do you agree that adolescents and young girls face the most consequences of unsafe abortion?








8. More than half the respondents agreed to this and a huge number of respondents didn't agree. Few were indifferent.

Do you think that unsafe procedures many people use for abortion has anything to do with it being criminalized in Nigeria?








10. According to the chart below, 152 of the respondents agreed that Nigeria has doctors who can provide safe abortion services.


Do you think there are qualified doctors/physicians in Nigeria who can provide safe abortion services for women/girls?

Do you think there are enough health facilities with access to safe abortion services in your community and state at large?









## 12. A huge number of respondents were not sure. But 38.1% agreed to know someone who has been harmed from abortion.

14. More than half of the response agreed that deaths from abortions will reduce if it is decriminalized.


Do you think death from unsafe abortions will reduce if abortion is decriminalized and safe abortion services are made available?

Do you think it is okay for an adolescent girl to ask her class teacher questions on the concept of abortion?








16. Majority agreed that CSE in secondary schools can teach girls about abortion and its consequences.

Comprehensive Sex Education in secondary schools can enlighten our young girls on unsafe abortion and it's consequences and thereby reduce it








17. From the image below Government, health and media agencies will be indeed needed to advocate about the results of unsafe abortion. As agreed by 130 respondents

Government polices/laws should be reviewed to allow access to safe abortion for women and girls









19. Majority of the respondents agreed to be able to talk and have conversations with their close groups on abortion.

#### **Recommendations and Observations:**

- As seen above, CSE in all levels from schools to government parastatals will be needed which will help in the process of reviewing laws and policies to support safe abortion.
- Engagement with mass media can help sensitise the masses on abortion as a health option and as a rights-based subject.
- Most people die as a result of unsafe abortion, according to the responses.
- Women gatherings and social groups in Delta State should be sensitised and engaged to create awareness on unsafe abortion and its consequences.
- During the process, respondents were reluctant to participate because of the word 'abortion'. More advocacy materials and discussions should be held to change people's perception on abortion and lessen the stigma attached to it.
- Parents/Teachers/Guardians should be sensitised to discuss SRHR matters with their adolescent children/wards.
- The health facilities in Oshimilli South, Asaba should be strengthened on creating awareness on unsafe abortion and its consequences and to provide access for safe abortion in their facilities.
- Develop quality advocacy tool used to educate the policy makers.
- Replication of such study in other local governments to capture larger sample size for comprehensive roll out of health programmes.
