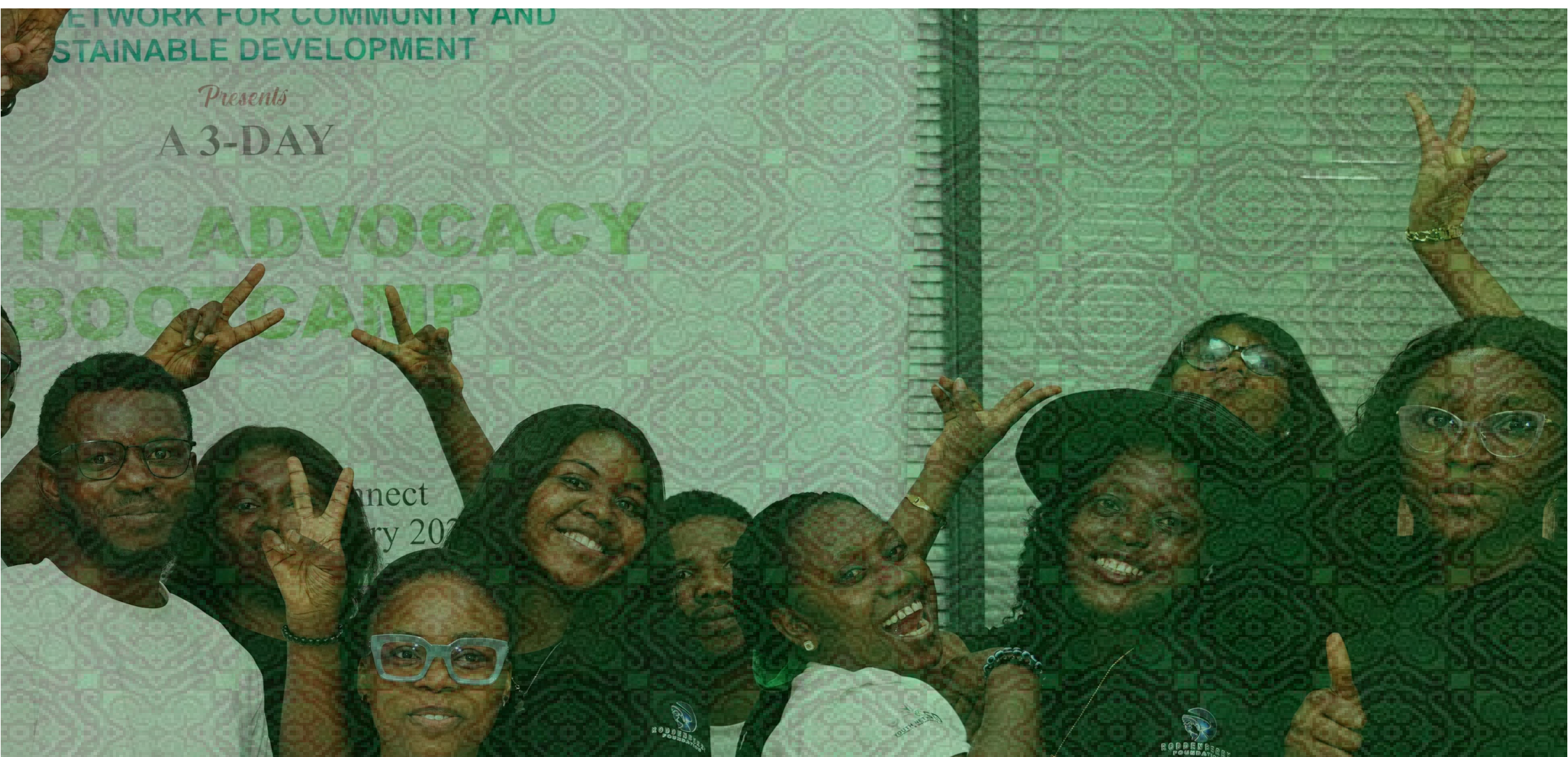

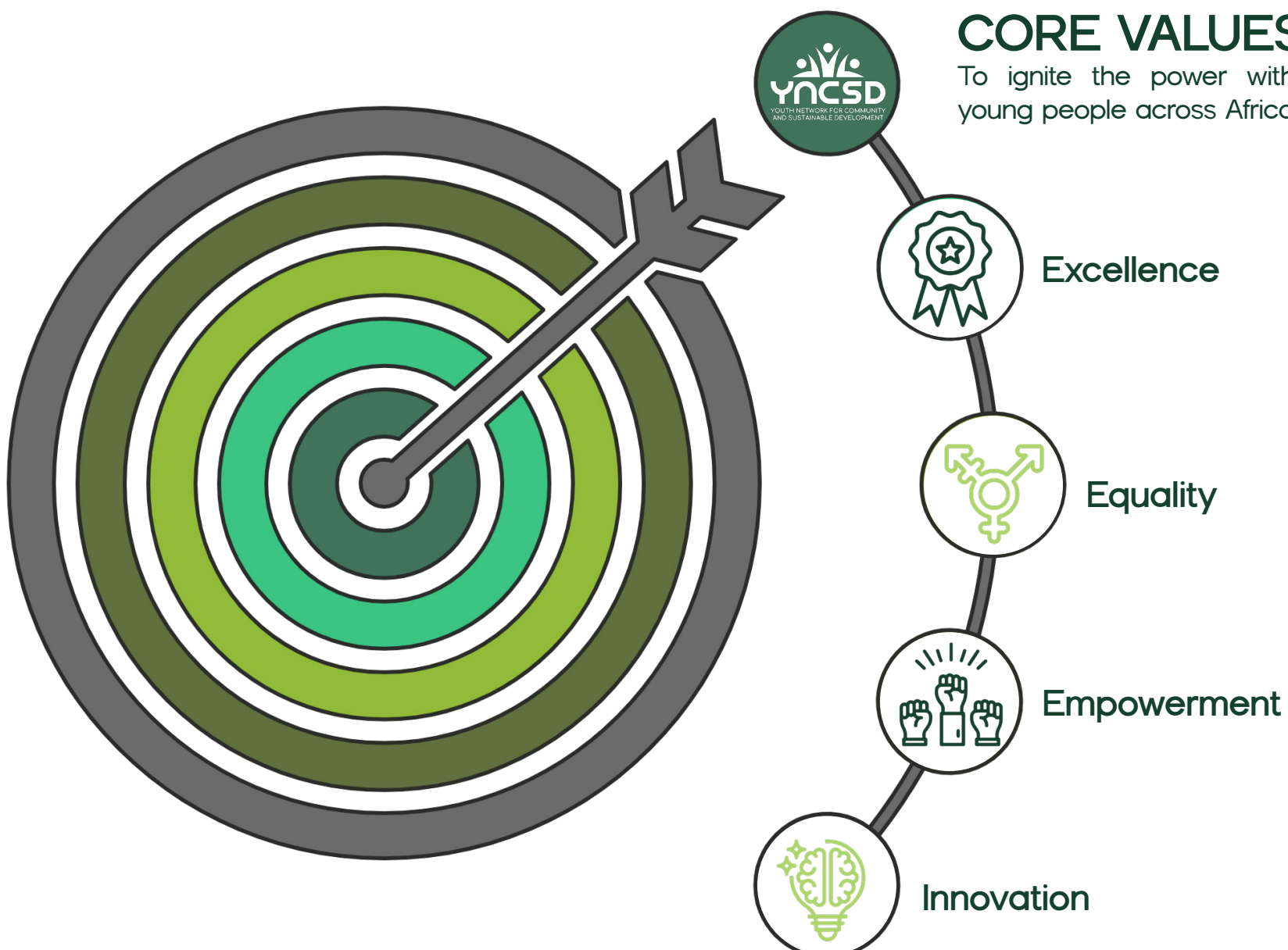

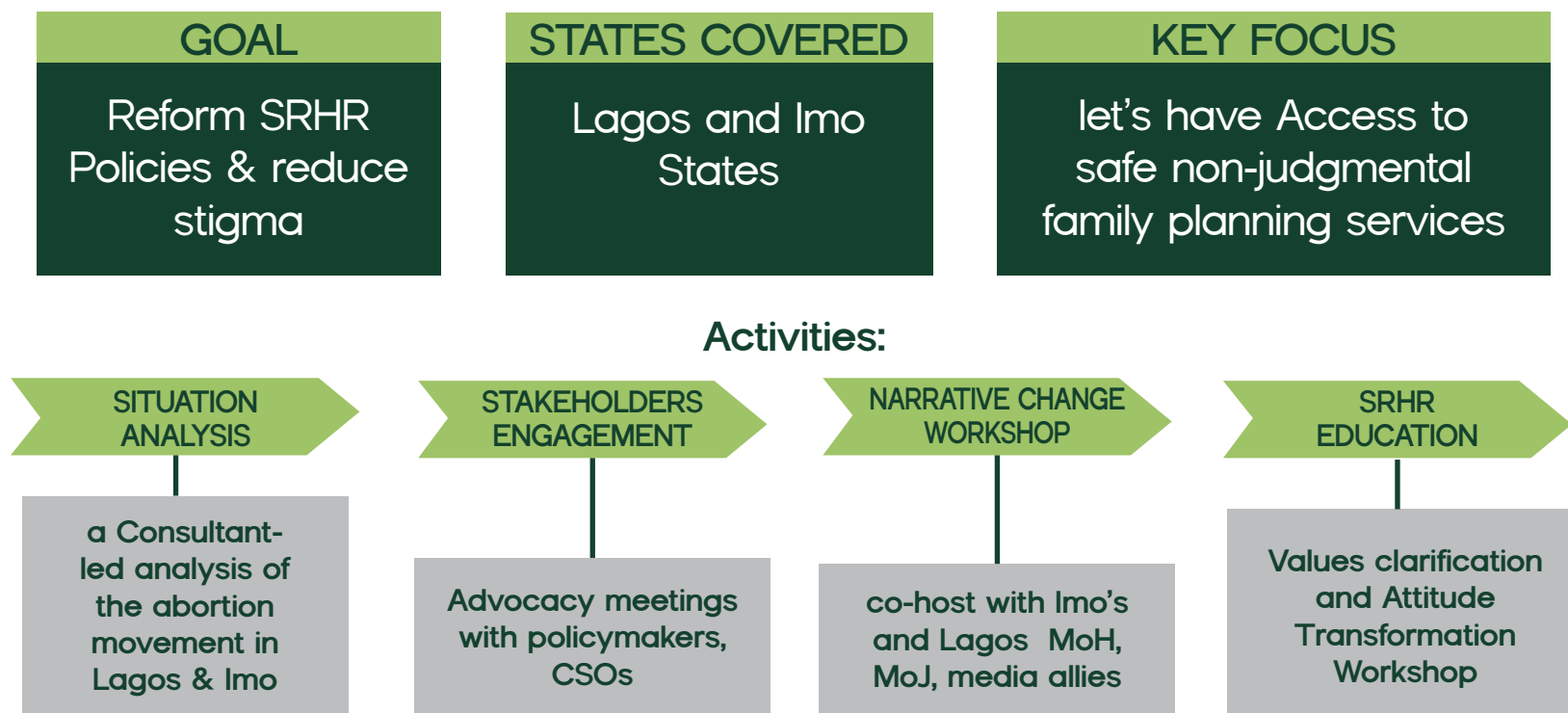

1. Accelerating Coordinated Advocacy for Improved SRHR Policies in Nigeria (Move2Act Project)

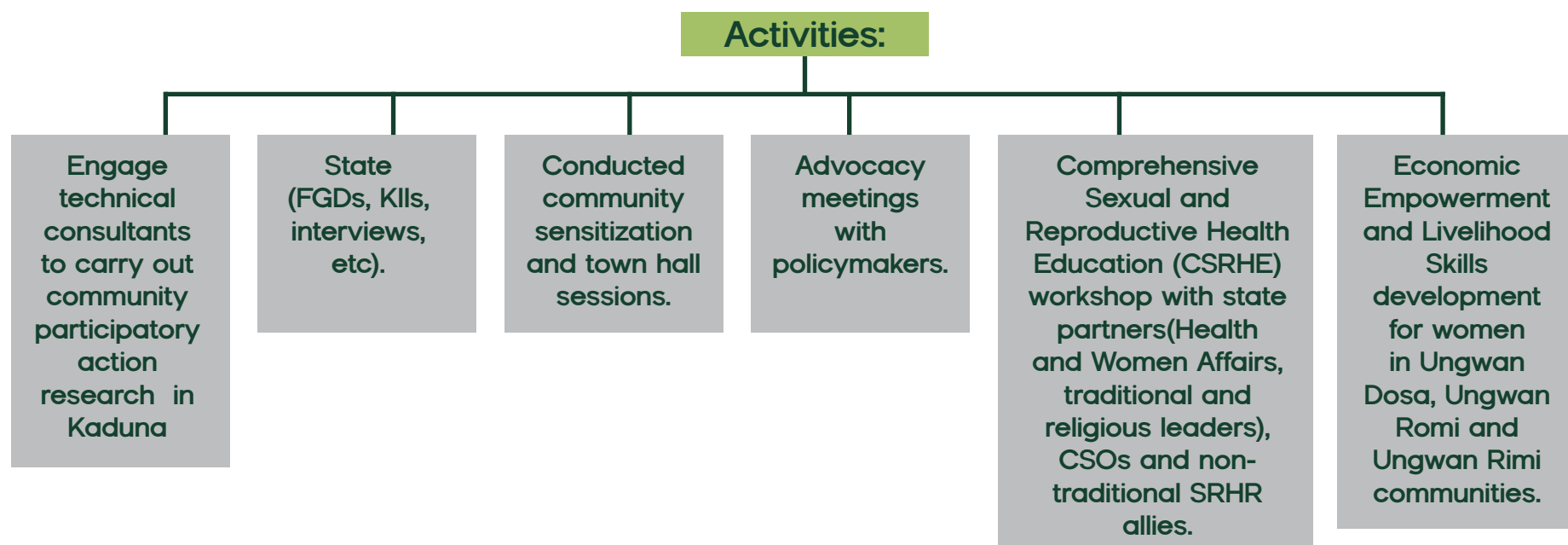

Stakeholders engaged (Legal experts, policymakers, CSOs actively participated in strategy discussions), Cross-sector collaboration (Ministries of Justice, Health, Women Affairs + Media = Broader support), Shifting the narrative (Community-level discussions and workshops reduced abortion-related stigma.).

2. Combating Child, Early and Forced Marriage (CEFM) Project in Kaduna State: To carry out awareness and advocate for policies addressing CEFM.

3. RAES Pamoja Known as the 'Tobasewo' Campaign: Improve adolescent girls and women access to safe SRHR services.

Activities:

Conducted specialized training sessions to equip 30 content creators with the competencies to craft and deliver more productive social media stories/ framing of SRHR and abortion storytelling.

Launched a targeted social media challenge/social media campaign to improve access to safe abortion services.

Creative industry collaboration with theatre and stage production directors/ producers to include positive safe abortion narratives in storytelling on television, radio, theatre productions and stage acts.

Impact:

Reached 45 young people who championed to create positive safe abortion narratives using media and in the creative industry.

4. Linking and Learning to Improve Access to Sexual and Reproductive Products and Information and Services (LINKS Project):



This project, We want to see more sexual and Gender Minorities and girls having unhindered access to information on their bodily integrity and autonomy. We also want to see that sex workers in FCT Abuja have access to their body agency. This means that fewer of these communities will have the need to walk into health facilities to access these services. In addition, we want to see that these communities have been trained on how to exercise agency over their bodies and sexual health so they can realize their full rights. We will do this through a peer-to-peer approach in training on agency, self managed abortion and through our hotlines.

Overall Impact in 2024

Completed peer education sessions for FSW and LBQ+ communities.

Conducted community outreach in identified communities in FCT- Abuja.



Response to Crisis:

This project will provide access to SRH unmet needs covering family planning, reusable pads and menstrual hygiene products for women, girls and gender minorities in IDP camps in Benue and Kogi states.

Activities:

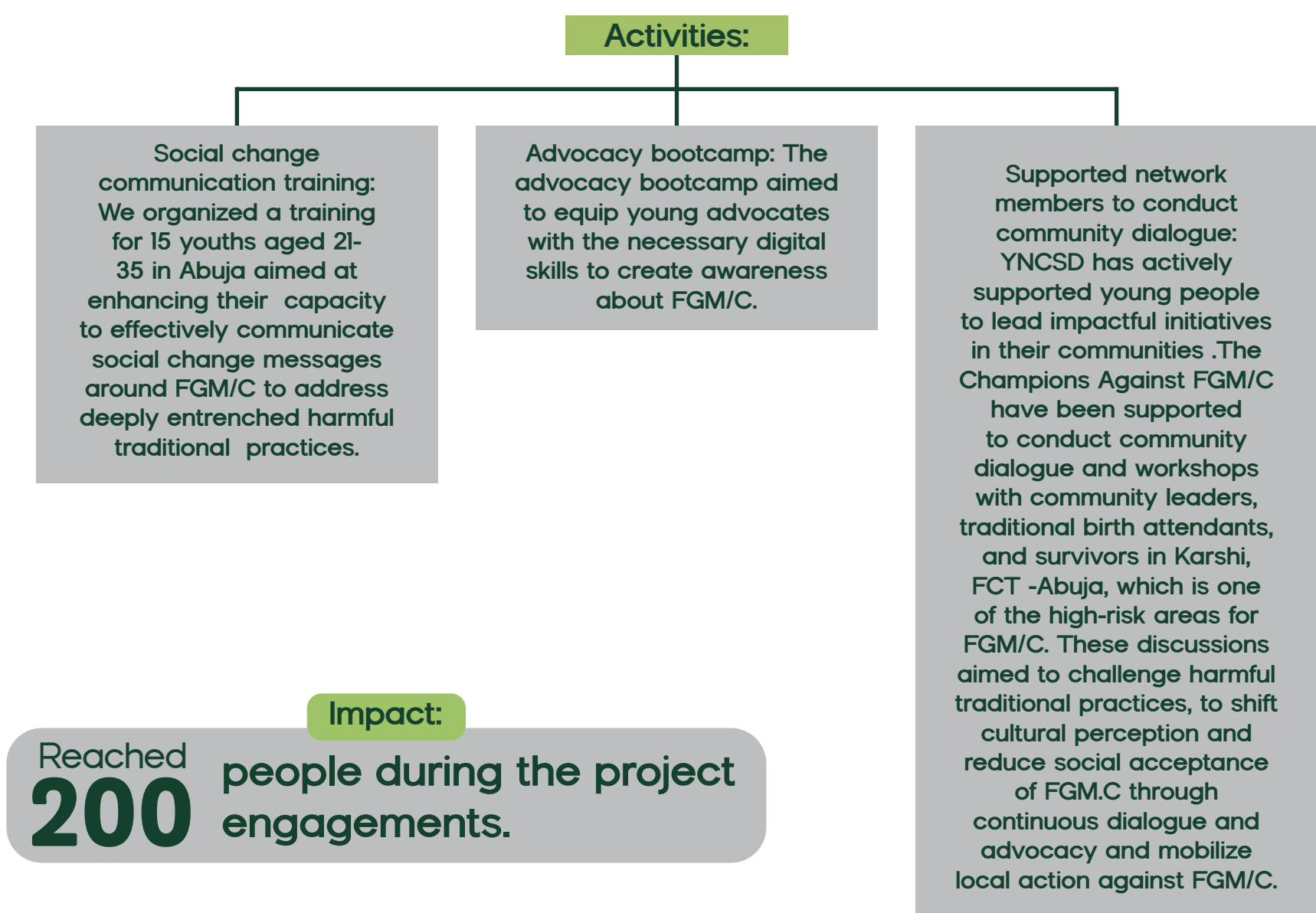
- Meeting with Remilekun Rachel from Participatory Initiative for Behavioral Change and Development(PIBCID): We engaged in a discussion with PIBCID and introduced the ongoing project to the organization.
- Visit to the Etsu of Adankolo Community where we introduced the project to the traditional ruler, seeking support and collaboration.
- Visit to Adankolo IDP Camp where we observed the camp, noting that it is currently empty but serves as a refuge during the flooding season.
- Visit to National Service Civil Defence Commission: Introduced the project to the gender desk officers, who also oversee the humanitarian unit. This provided an opportunity to align the project with their ongoing efforts.
- Courtesy Call to the Traditional Ruler of Gadumo Community: Extended greetings and reintroduced the project, reinforcing support and collaboration.
- Visit to Gadumo IDP Camp: Assessed the camp's status, noting that it is empty but will be occupied during the flooding season.
- Visit to State Emergency Management Agency (SEMA), Kogi State: Reintroduced the project to the new Executive Secretary of SEMA in Kogi State, receiving positive feedback and showing strong interest in collaboration.
- Visit to Global Women's Health and Rights Initiative, Benue: Introduced the project to the organization, represented by the programs officer due to the absence of the Executive Director.
- Visit to SEMA, Benue State: Secured project approval from the Executive Secretary through representatives Mr. Solomon(Head of Department, Relief and Rehabilitation) and Donald(Head of Admin), affirming the project's alignment with local needs and gaining access to the identified camps in Benue State.
- Visit to Ichwa and Abagena IDP Camps: Assessed these IDP camps in Benue State, understanding their conditions and needs.

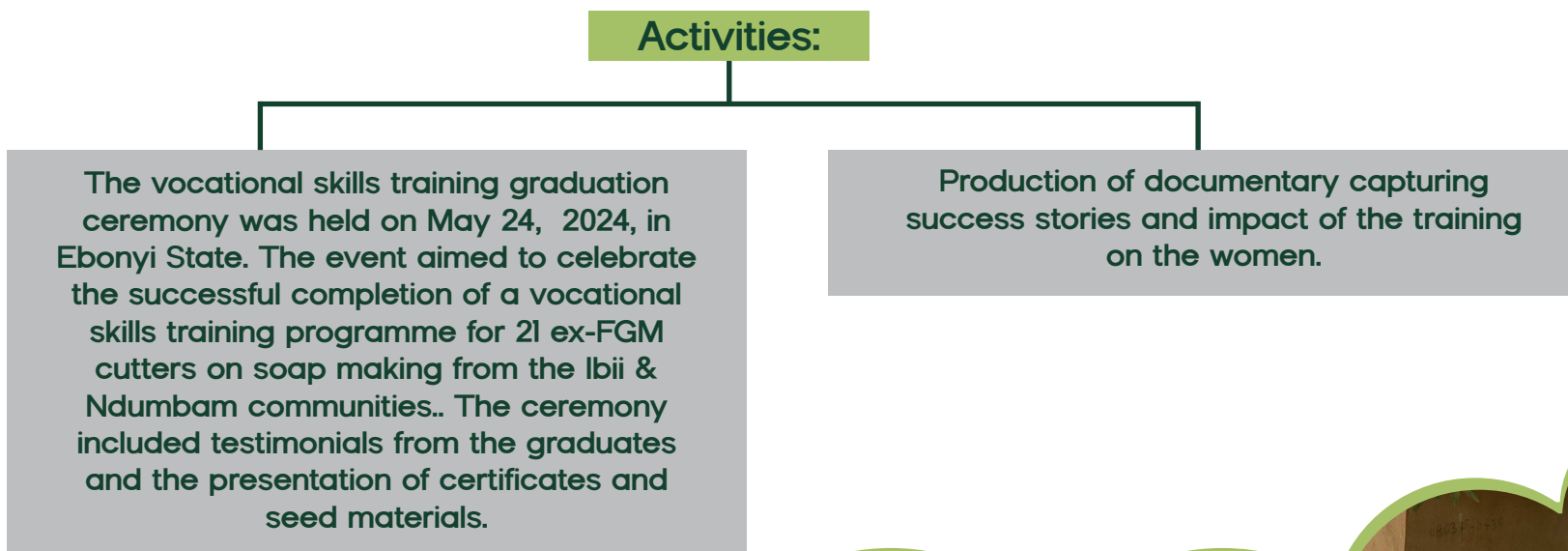

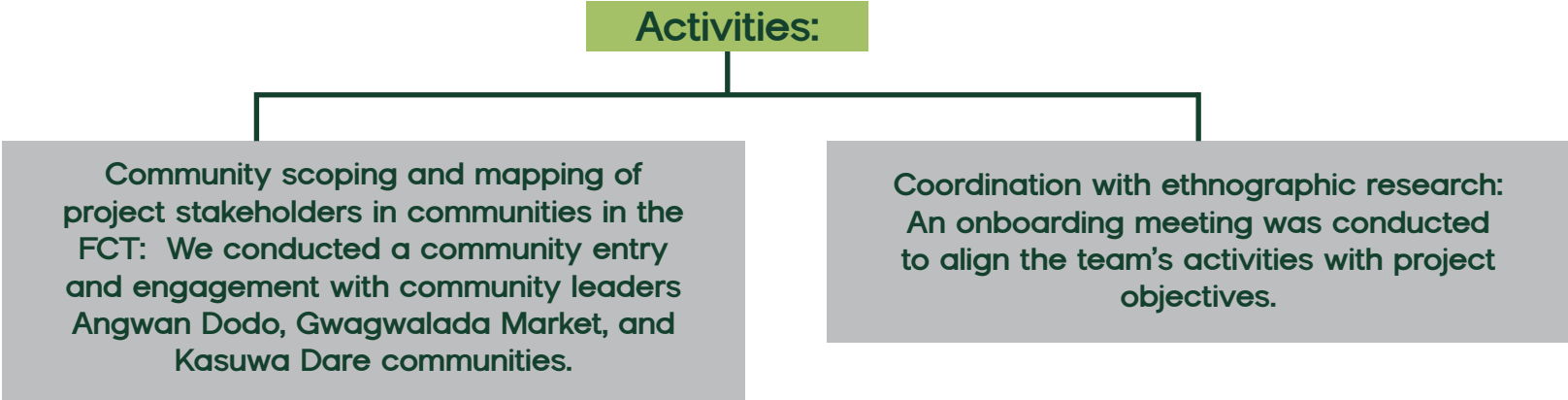

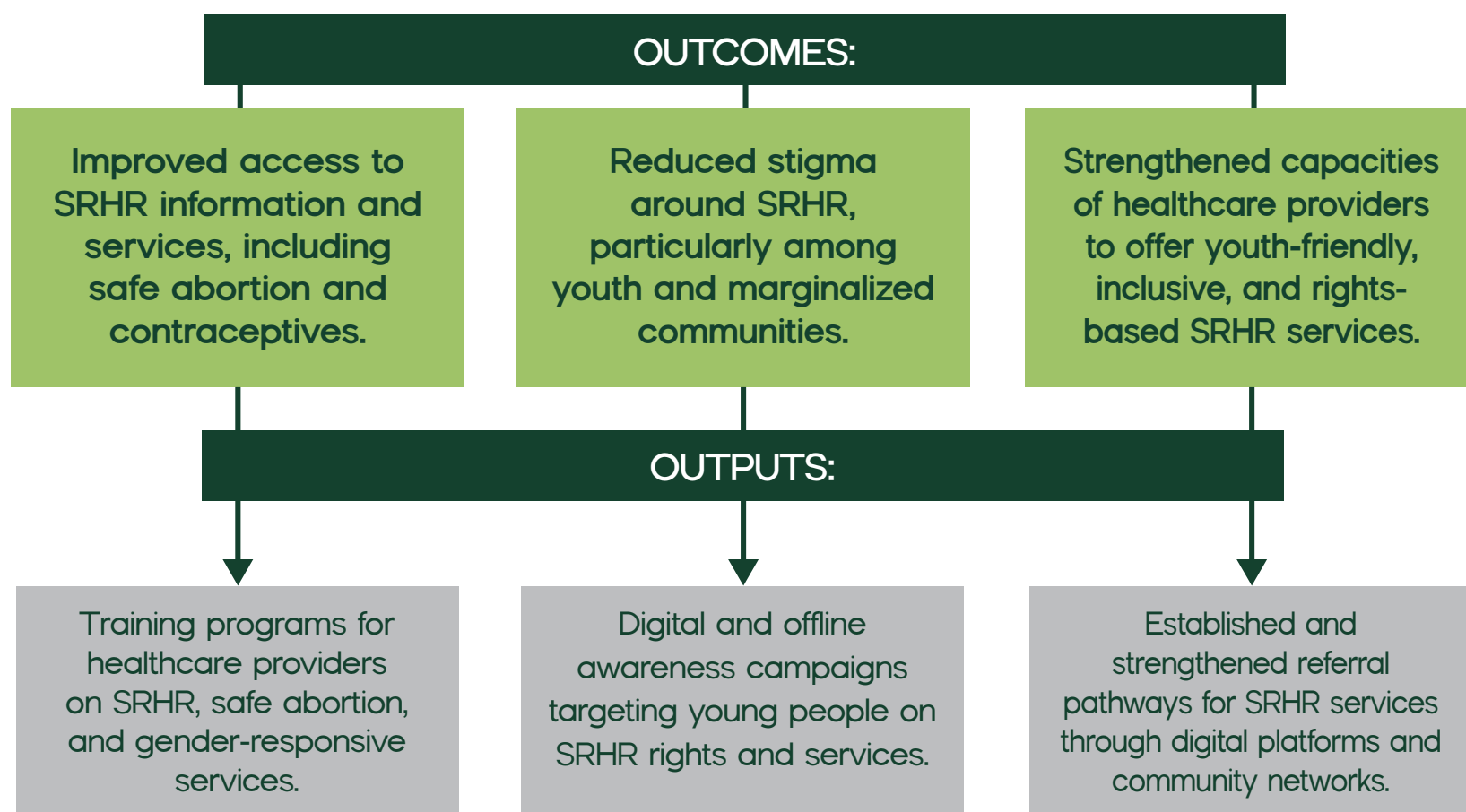
Theory of Change for YNCSD (2024-2029)

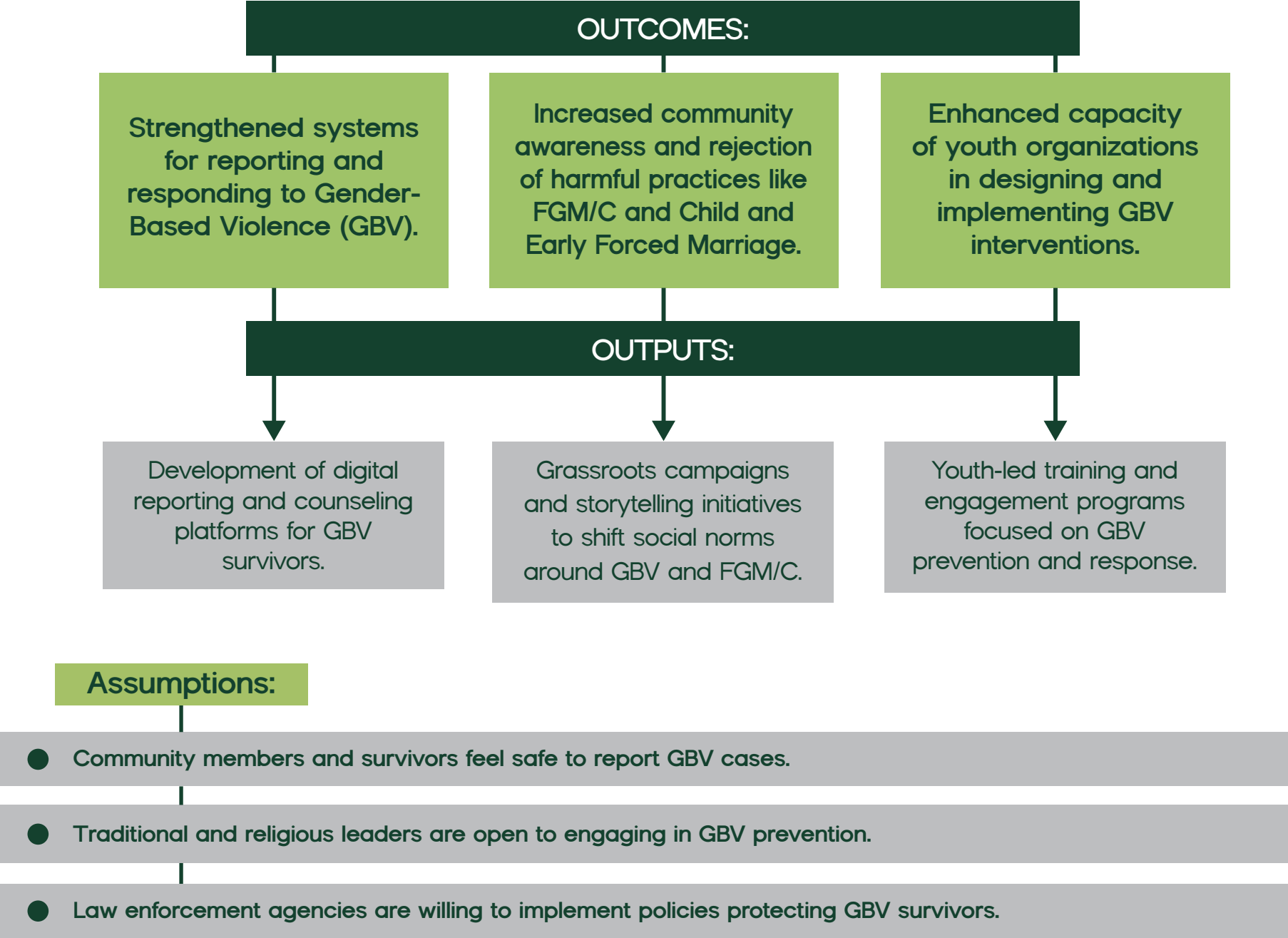

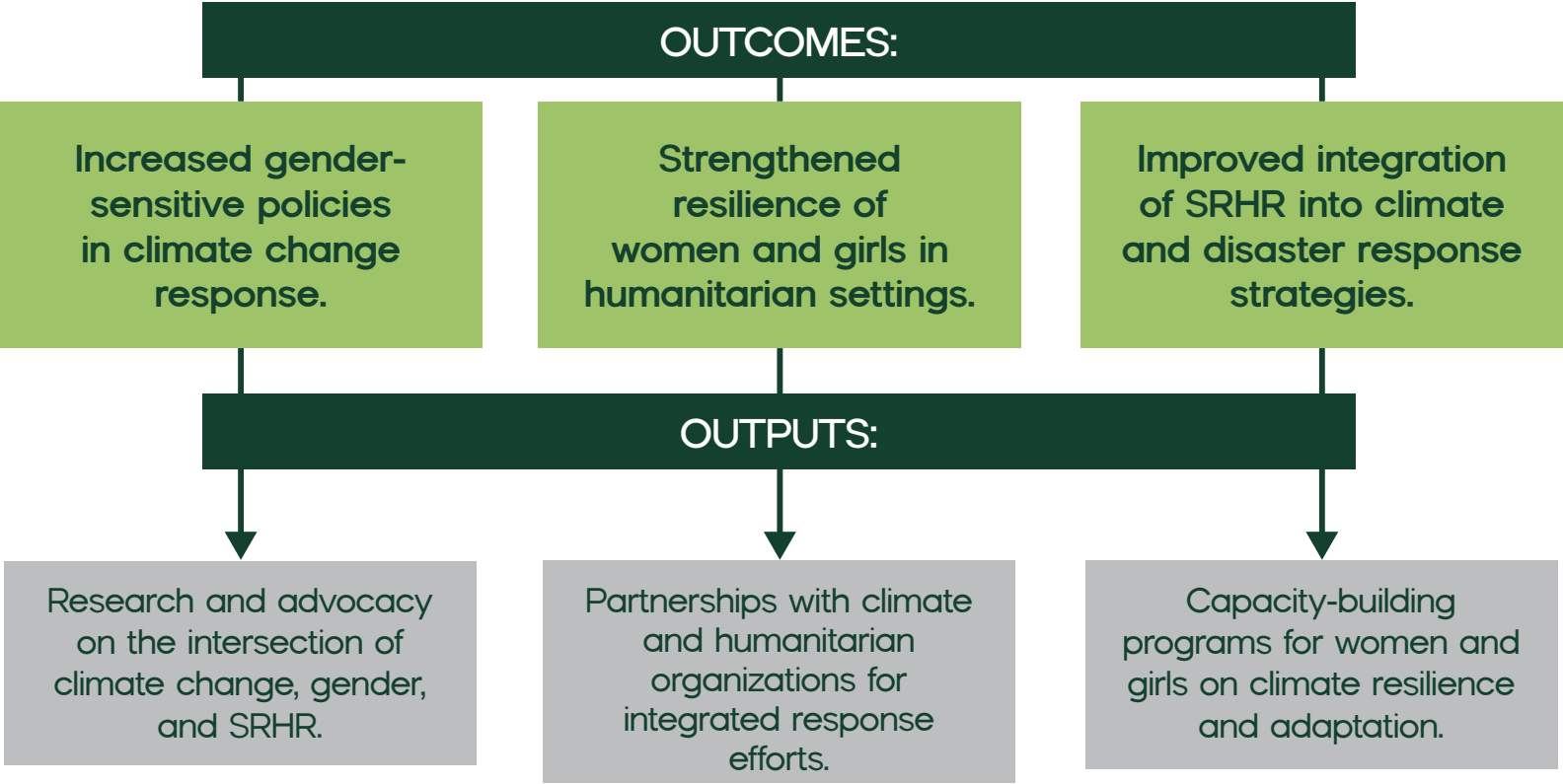

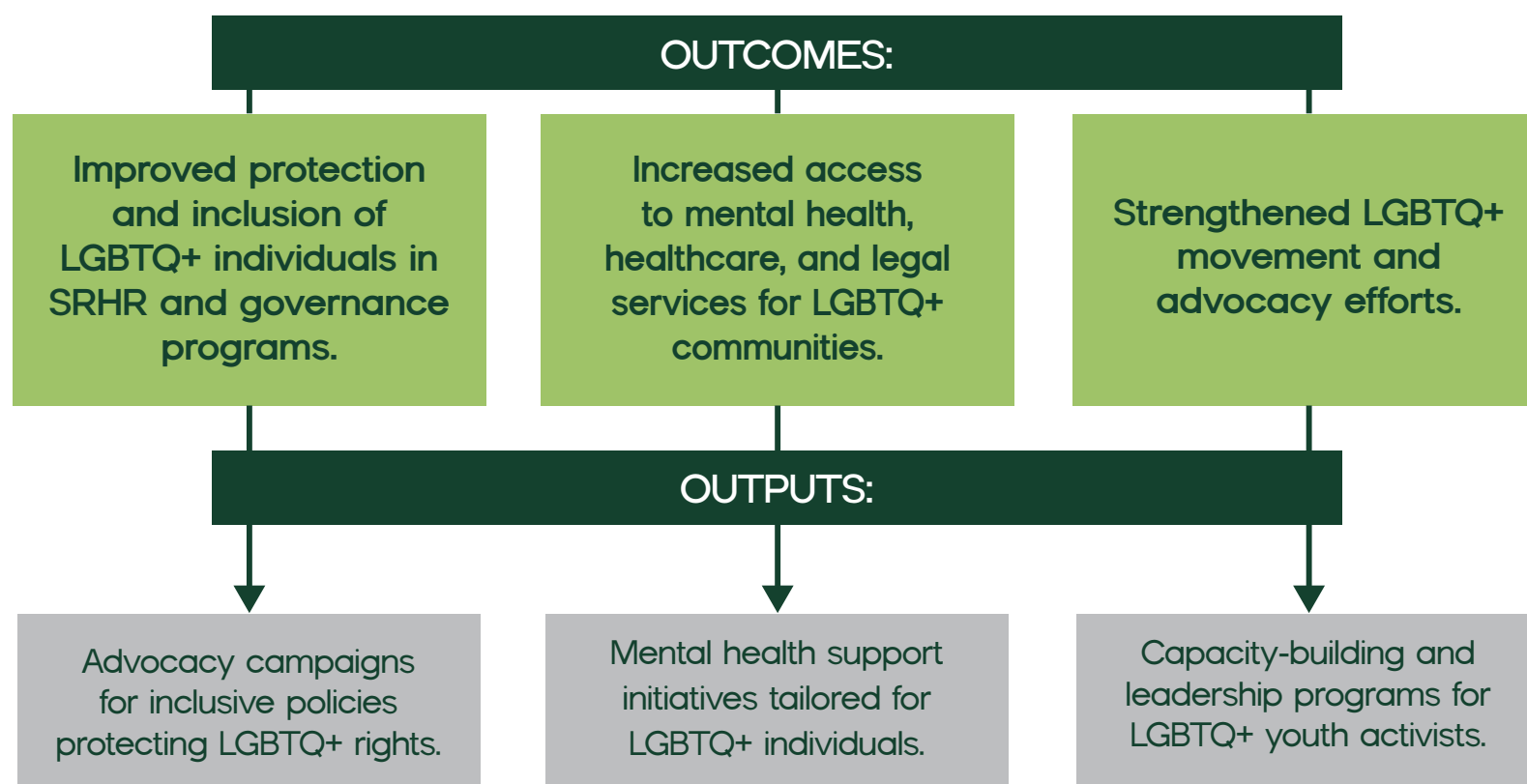

Strengthening Advocacy Through Values Clarification and Attitude Transformation (VCAT) Training.

As part of our commitment to advancing Sexual and Reproductive Health and Rights (SRHR), the Youth Network for Community and Sustainable Development (YNCSD) successfully hosted a Values Clarification and Attitude Transformation (VCAT) Training under the Move2Act Project and Pamoja Project in Lagos State. This transformative session aimed to challenge biases, shift perspectives, and equip advocates with the tools needed to promote safe abortion rights and gender equality.

The training brought together key stakeholders, including healthcare providers, women-led organizations, legal experts, and youth advocates, fostering open dialogue on restrictive abortion laws and their impact on marginalized groups. Through interactive exercises, real-life case studies, and strategic discussions, participants deepened their understanding of SRHR issues and strengthened their commitment to rights-based advocacy.

Key sessions included:

- Understanding Biases in SRHR Advocacy – Encouraging self-reflection and unpacking deeply rooted societal stigmas.
- Policy and Legal Landscape – Exploring Nigeria's abortion laws and identifying pathways for legal reform.
- Strategic Advocacy Approaches – Equipping participants with tools to influence policy change and drive impactful storytelling.
- Technology in Advocacy – Leveraging digital tools and media to amplify SRHR advocacy efforts.

This training not only enhanced participants' capacity to lead impactful advocacy but also set the stage for collective action towards progressive policy reforms. By fostering a network of informed and empowered advocates, the Move2Act and Pamoja Projects are driving Nigeria closer to achieving reproductive justice and gender equality.



Girls First Fund Team Visits Nigeria, Engages Communities in Kaduna State



As part of efforts to strengthen partnerships and enhance community-led initiatives addressing Child, Early, and Forced Marriage (CEFM), the **Girls First Fund (GFF) team** recently visited Nigeria to engage with project stakeholders and beneficiaries in **Kaduna State**. The visit was a significant milestone in the ongoing collaboration between **Youth Network for Community and Sustainable Development (YNCSD)** and GFF, aimed at fostering sustainable solutions to protect and empower young girls.

During the visit, the GFF team met with **traditional and community leaders, women’s groups, local advocates, and young girls directly impacted by the CEFM Project**. These interactions provided a platform for open dialogue on the root causes of CEFM and the progress made in tackling this issue through grassroots advocacy, economic empowerment programs, and legal enforcement efforts.

A key highlight of the visit was a **community town hall meeting**, where survivors of child marriage shared their experiences, shedding light on the urgent need

for **education, legal protection, and economic opportunities** for young girls. Local leaders and stakeholders reaffirmed their commitment to enforcing the **Child Rights Act**, ensuring that girls remain in school and have access to opportunities for self-development.

The Girls First Fund team also **conducted site visits to project locations**, where they observed the implementation of community-driven interventions, including **mentorship programs, skills training, and advocacy campaigns** led by YNCSD. The team commended the resilience of the local advocates and pledged continued support for initiatives driving systemic change in the fight against child marriage.

The visit reinforced the importance of **collaboration, policy advocacy, and grassroots engagement** in addressing child marriage in Nigeria. As YNCSD continues to champion the rights of young girls, the partnership with Girls First Fund remains instrumental in scaling impact and ensuring that every girl has the right to a future free from forced marriage.

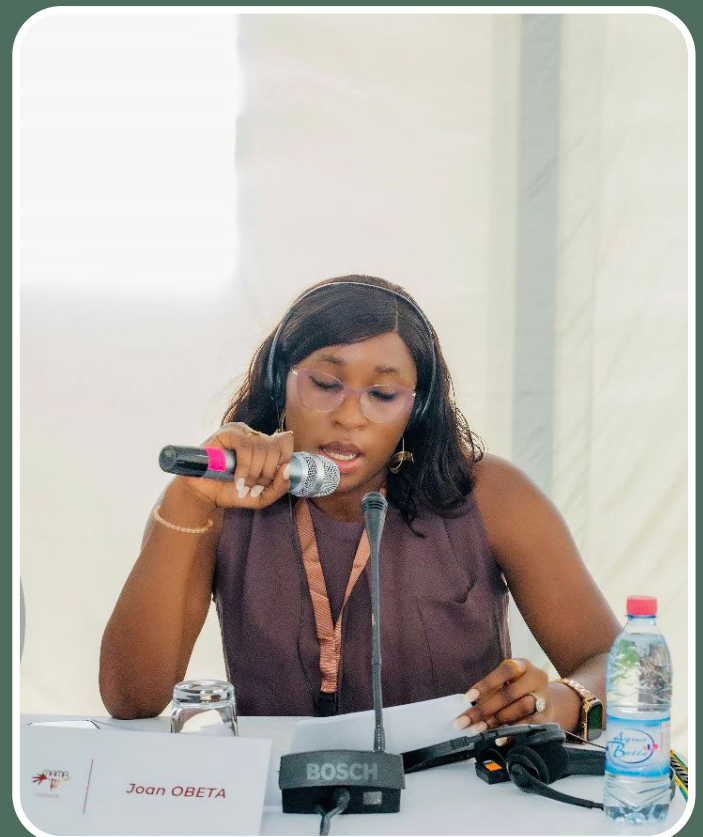
